The company's specialties are modular cam switches and switch disconnectors. Kraus & Naimer is a strong partner for customers from many areas, such as transport (trains, vehicles, ships, etc.), conveyor systems, lift systems, mechanical engineering and in power generation and distribution systems. The family business, which has been run by Joachim (Ted) L. Naimer in the third generation since 2004, is the world market leader in the field of cam switches and has brought forth numerous innovations. As early as 1948, the company introduced the world's first modular cam switch (C15), which made it possible for the first time to manufacture customer-specific products. Even the smallest cam switch in the world (model CA4N) comes from Kraus & Naimer. The company operates six production facilities for the manufacture of its products - with the largest production facility in Weikersdorf, Lower Austria - 18 group-owned sales and consulting companies and employs around 900 people worldwide. *

To better serve the global market, a worldwide sales network with independent branches was set up. The country-specific organizations ran under the name SOLENOID, which should underline the accompanying but independent function. Kraus & Naimer's head office opened its own sales company in the Netherlands on June 1, 1964 - 'De NEDERLANDSE SOLENOID'. After the merger with the 'Belgian Solenoid' in 1994, the name was changed to 'Solenoid Benelux BV' in order to be able to operate as a unit in the Benelux countries. The goods are delivered from Hengelo (O) to the Netherlands, Belgium and Luxembourg. In addition to the office in Hengelo, there is also an office in Zaventem (Belgium), Barcelona and an agency in the Caribbean. On January 1, 2009 the term SOLENOID was changed worldwide and updated for Holland in KRAUS & NAIMER Netherlands to establish an even better relationship with the parent company in Vienna.

Kraus & Naimer Netherlands has been headed by Bert Koershuis since March 2018.
